**PRESENTATION:** This one day training will provide current recommendations for pressure ulcer prevention, wound etiology recognition and wound treatment, with an emphasis on assessment and documentation that meet federal mandates and guidelines from the National Pressure Ulcer Advisory Panel.

This presentation will provide a combination of training on pressure ulcer prevention and treatment, as it relates to nursing clinical competencies as well as on wound staging and documentation. Attendees will learn how to assess and evaluate residents that are at risk for skin integrity issues and appropriate interventions. Included in the presentation on wound care will be a discussion on current standards of practice relating to wound care treatment and prevention in long term care.

**PRESENTER:** Willie Ann Thomas has over 25 years' experience in nursing, wound care and education. She received her bachelor degree in nursing at Mississippi College and holds certifications in foot care nursing and wound, ostomy, continence nursing (WOCN). She has worked with State Surveyor, Licensure & Certification, Pressure Management Resource Company in Tennessee, a Home Health Agency in the Delta and Information and Quality Healthcare providing education to both nurses and patients. She is Senior Lead educator for the Diabetes Education and Empowerment Program (DEEP). She trains diabetes educators in DEEP teaching methods and holds educational classes for people with diabetes throughout the state with the Everyone with Diabetes Counts for Information & Quality Healthcare (IQH) in Mississippi.

## DIRECTIONS TO MHCA OFFICE – From South Mississippi

Go North on I-55 (Grenada/Memphis). Take Old Agency Road Exit 105C toward Ridgeland. Turn slightly right onto Old Agency Road. Move over to far left so that you will enter the Roundabout correctly. Take the 3<sup>rd</sup> exit in the Roundabout which will put you onto Highland Colony Parkway. Go approximately 1 mile. Will see a Large Assisted Living Complex on left called Beau Ridge. Immediately past this you will take a left onto Brame Road. Will see a building on the right which is MHCA office. Take the first right after turning onto Brame Road which will be into MHCA parking lot.

## DIRECTIONS TO MHCA OFFICE – From North Mississippi

Go south on I-55. Take Old Agency Road Exit 105B toward Ridgeland. There are two lanes to exit. Keep Right to take the Old Agency Road Ramp then will veer to right. Move over to far left so that you will enter the Roundabout correctly. Take the 3<sup>rd</sup> exit in the Roundabout which will put you onto Highland Colony Parkway. Go approximately 1 mile. Will see a Large Assisted Living Complex on left called Beau Ridge. Immediately past this you will take a left onto Brame Road. Will see a building on the right which is MHCA office. Take the first right after turning onto Brame Road which will be into MHCA parking lot.
