## DIRECTIONS TO MHCA OFFICE – From South Mississippi

Go North on I-55 (Grenada/Memphis). Take Old Agency Road Exit 105C toward Ridgeland. Turn slightly right onto Old Agency Road. Move over to far left so that you will enter the Roundabout correctly. Take the 3rd exit in the Roundabout which will put you onto Highland Colony Parkway. Go approximately 1 mile. Will see a Large Assisted Living Complex on left called Beau Ridge. Immediately past this you will take a left onto Brame Road. Will see a building on the right which is MHCA office. Take the first right after turning onto Brame Road which will be into MHCA parking lot.

## DIRECTIONS TO MHCA OFFICE – From North Mississippi

Go south on I-55. Take Old Agency Road Exit 105B toward Ridgeland. There are two lanes to exit. Keep Right to take the Old Agency Road Ramp then will veer to right. Move over to far left so that you will enter the Roundabout correctly. Take the 3rd exit in the Roundabout which will put you onto Highland Colony Parkway. Go approximately 1 mile. Will see a Large Assisted Living Complex on left called Beau Ridge. Immediately past this you will take a left onto Brame Road. Will see a building on the right which is MHCA office. Take the first right after turning onto Brame Road which will be into MHCA parking lot.
