Participants in this intensive focus day will learn about the Center of Excellence for Behavioral Health in Nursing Facilities (COE-NF). The session will begin with an overview of the Substance Abuse and Mental Health Services Administration (SAMHSA) and the Centers for Medicare and Medicaid Services (CMS) grant, highlighting its national success. An overview of the services and support available will also be provided.

Learners will gain insights into how the Behavioral Health Needs Assessment tool and the Behavioral Health Ambassador Program can identify strategic steps to support residents.

Additionally, findings from recent survey updates regarding behavioral health will be shared, including the importance of documentation for antipsychotic medication use.

Participants will receive staff tools for preventing escalation in challenging situations, and various opportunities for technical assistance from the COE-NF will be highlighted.
